Arnaldo Peroni	(Consultant OP LATIUM e Operations Manager of the Program) - Responsible for the operational management of the "ECCEUKCH" project. He is called upon to participate in the governance of the programme of activities by examining and verifying the completeness and correctness of the tasks carried out in correspondence with each work package (WP), with particular regard to the work of contracted suppliers; assists in the drafting of the monitoring protocol and the interim and final reports. He will also carry out the duties of secretary of the Technical Commission.
